## the reception: restaurant, marquee or kitchen garden

Poachers Pantry has three venues, the smart but casual restaurant, our beautiful marquee and the kitchen garden.

### THE SMOKEHOUSE RESTAURANT

The restaurant with its wooden floors and stone fireplace is wrapped by a terrace and deck and overlooks the classic slab woolshed and kitchen garden.

### THE MARQUEE


The marquee is set in its own grounds with lawn and gazebo and is a blank canvas for you to make your own.

### THE KITCHEN GARDEN

The kitchen garden is a delightful outdoor space for a smaller wedding – with the restaurant as the wet weather option.

Where you choose to have your reception will depend on the number of guests you intend to invite. Including space for a dance floor, the restaurant can seat up to 65 guests and the marquee can seat up to 240 guests.

Daytime receptions can only be held on a weekday.

### terms & conditions

The staff at Poachers Pantry (Fumage Pty Ltd ABN 49058335818) are committed to providing you and your guests with a wedding that will be a great success. Listed below are our terms and conditions; see the pricing schedule and inclusions and extras schedule for the complete pricing details.

- **1. Confirmation of a booking:** forward a completed copy of the wedding details and signed terms and conditions, along with a non-refunadable deposit of \$2000. Your booking will not be secured until the deposit is received. If payment is not made by the invoice due date, Poachers reserves the right to rebook the date.
- **2. Seasonal package prices are not quotes:** A quote that is provided is indicative only. Your wedding costs reflect the pricing that is applicable for the wedding season that your wedding falls in.
- **3. Final event details and catering requirements** are required 28 days before the event. This includes room set up, menu selection, beverage requirements, entertainment and equipment needs, number of guests and wedding duration. Additional labour charges will be incurred for last-minute changes to a previously agreed room layout. With the exception of your wedding cake, Poachers Pantry reserves the right to exclusively supply the food and beverage for your function. Changes to numbers within 28 days of your weddings will not be refunded.
- 4. Fee for the cancellation of a confirmed wedding:
- $\cdot$  With less than 6 months notice is equal to the deposit plus 25% of the estimated total cost.
- · With less than 3 months notice is equal to the deposit plus 50% of the estimated total cost.
- **5. Public Holiday and New Year's Eve** incur a 20% surcharge to the food and beverage cost.
- **6. Extended hours surcharge:** If your guests remain on the property after midnight or are on the premises for longer than 6.5 hours without prior agreement by Poachers Pantry, a surcharge as per the fees schedule will be charged.
- 7. Venue hire / Minimum spend: please refer to the pricing schedule.
- **8. Security hire:** wedding receptions held in the marquee are subject to a security hire fee. An external security company will be hired at your expense (cost only) to ensure the safety of Poachers' staff and your guests.
- **9. The use of the ground:** The grounds, including the homestead lawn, marquee lawn, the rural landscape, and old farm buildings can be used for the ceremony, canapés, and /or photography. The charge for access to the grounds is applicable to all weddings. In the event of rain you may still use the outdoor areas of the venue but we reserve the right to refuse service due to weather and will provide an alternative location indoors.
- 10. The clients are financially responsible for any damage to the company's property or any property in its care or custody made by the clients' guests, suppliers or other persons attending the wedding. No responsibility for damages or loss to equipment or merchandise left on the premises prior, during and after the function is accepted by the company. Insurance cover for personal equipment and merchandise is recommended.
- 11. Wedding decorations and access: The client is responsible for the supply, set up and removal of all decorations. Access to the grounds and marquee is from 10:00 am on the day of the function, access to the restaurant is from 5:30 pm on the day of the function. All decorations must be removed from the venue by 9:00 am on the morning following the function. Goods left more than 48 hours will be disposed of at a cost to the client. Your credit card details are required to be provided during your final wedding meeting for Poachers to charge for extras costs incurred on the day of your wedding i.e. hours extension, bar tab.
- 12. Price variation: due to the fluctuations in food, beverage, staffing and associated costs, Poachers may increase costs without notice. Wedding pricing is reviewed annually, and may be subject to increase prior to each wedding season (Sept), at which point all upcoming weddings will be notified of the price change via email correspondence.
- **13. Payment milestones:** 30% of the invoice is due at 6 months, 30% at 3 months and the balance one month prior to your wedding day.
- **14. Menus** are subject to change without notice due to the availability and seasonality of ingredients and changes in staff.
